Effective 01 January, 2014 the Passenger Service and Security fees applicable to the Norman Manley International Airport and the Sangster International Airport were increased.

Exemptions:

Exemptions at the international airports include:

- a) Diplomatic aircraft
- b) Test flights
- c) Emergency landings

Exemptions at the domestic aerodromes include:

- a) Military arrivals
- b) Involuntary arrivals

Methods of Payment

All Landing, Parking, Passenger and Security services charges mentioned in this entire AIP Supplement are payable at the time the aerodrome is used or, in the case of regular users, on demand at the end of each calendar month in respect of charges accruing during the month.

1. NORMAN MANLEY INTERNATIONAL AIRPORT

1.1 The N.M.I.A. Ltd. (Norman Manley International Airport Limited) is responsible for all operations at the Norman Manley International Airport. All applicable fees are payable to N.M.I.A. Ltd. and are outlined in the ensuing subparagraphs.

1.2 **Landing Charges**

Landing fees for an aircraft are assessed on the basis of the MTOW (Maximum Take-Off Weight). The MTOW is the maximum Kilogram weight with which an aircraft can achieve flight, and is the sum of the weights of the airframe, fuel, cargo, and personnel.
