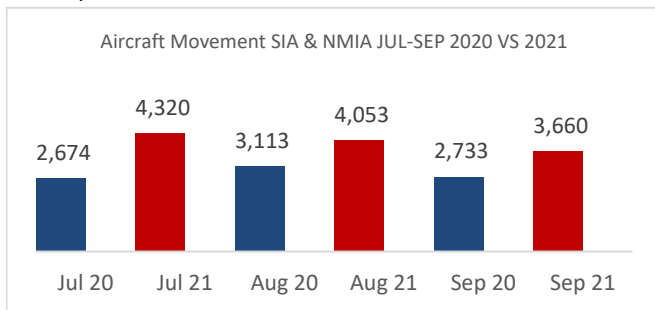

Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period July to September 2021 were **12,033**, an increase of **27%** when compared to the **9,447** aircraft movement recorded in the same quarter in 2020.



Year to date, January to June 2021, aircraft movements at SIA & NMIA increased by **11%**, with **33,207** aircraft movements compared to **29,905** in 2020.

Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the third quarter 2021 totaled **4,936**, a decrease of **6%** when compared to same period in 2020 where movements were **5,235**. Of the total aircraft for the 2021 period, **2,534** were international scheduled aircraft, **16** domestic aircraft, **1,616** military aircraft and **770** private aircraft. For the 2020 period of the **5,235** aircraft, **2,107** were international scheduled aircraft, **20** international non-scheduled, **21** domestic aircraft, **2,327** military aircraft and **760** private aircraft.

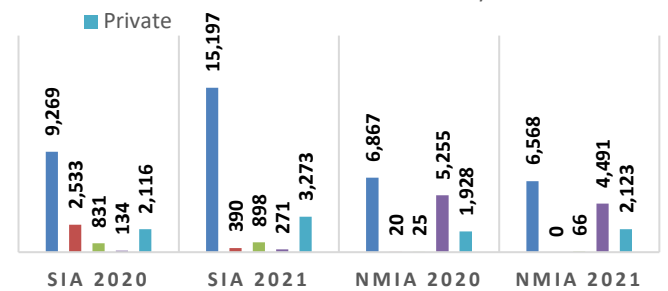
Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the third quarter of 2021 were **7,097** compared to **3,285** aircraft in the same period in 2020, an increase of **116%**. Of the aircraft for the 2021 reporting period **5,532** were international scheduled, **145** international non-scheduled, **285** domestic aircraft, **69** military aircraft and **1,066** private aircraft. For the 2020 period of the aircraft **2,539** were international scheduled aircraft, **173** international non-scheduled, **199** domestic aircraft, **29** military aircraft and **525** private aircraft.

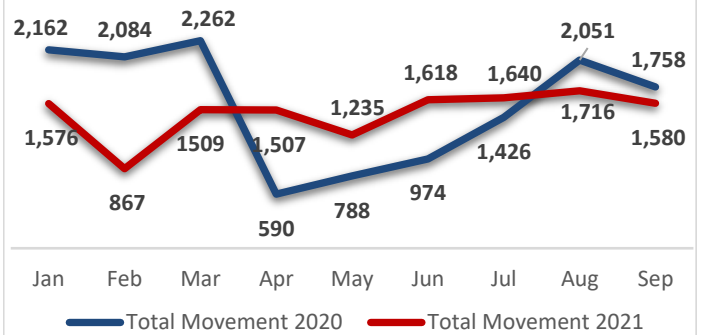

AIRCRAFT MOVEMENT SIA & NMIA JAN - JUL 2020 & 2021

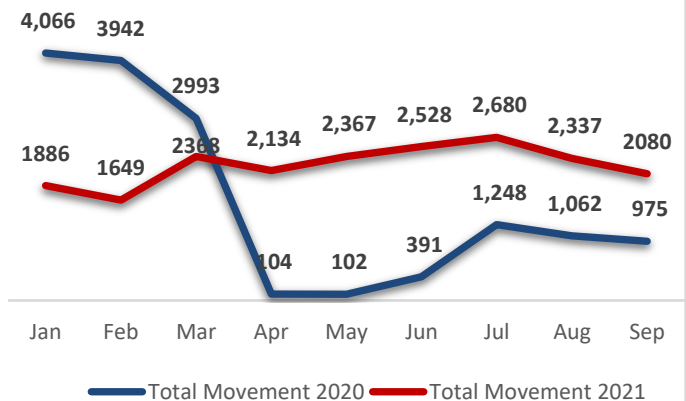
■ Int'l Scheduled ■ Int'l Non-scheduled

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period July to September 2021 at the domestic aerodromes and IFIA were **1,947** an increase of **98%** from the **991** aircraft recorded for the same period in 2020.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **77%** to **933** aircraft; **467** arrivals and **466** departures, conversely for same period in 2020, **527** aircraft were recorded; **263** arrivals and **264** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the July to September 2021 period. Movements increased by **138%** to **846** aircraft from **356** aircraft reported for the 2020 period. Arrivals and departure for the 2020 period were **180** and **176** respectively, whereas the 2021 period recorded equal arrivals and departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA increased by **130%** to **124** with **63** landings and **61** takeoffs. Movements for the 2020 period were **54** aircraft with **equal** landings and takeoffs.

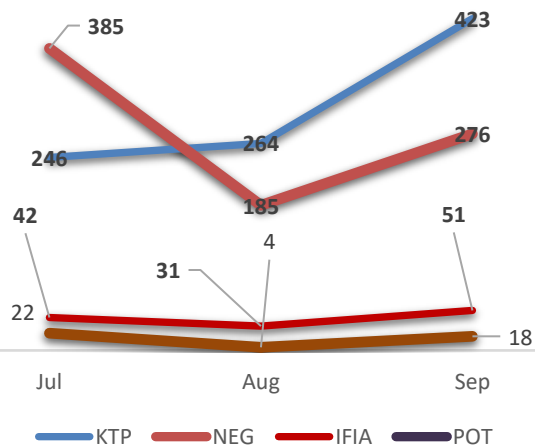
KEN JONES (POT)

Ken Jones Aerodrome noted **44** aircraft movement from July to September 2021. This was a **19%** dip from **54** aircraft arrivals and departure for the period in 2020. There were equal arrivals and **departure** in 2021 and **29** arrivals and **25** departures in 2020.

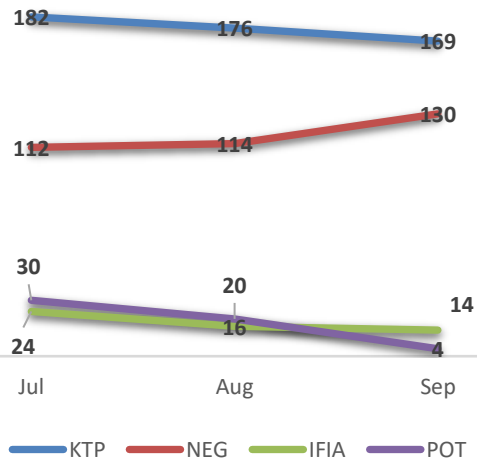

Aircraft Movements at Domestic Aerodromes Jul - Sep 2021



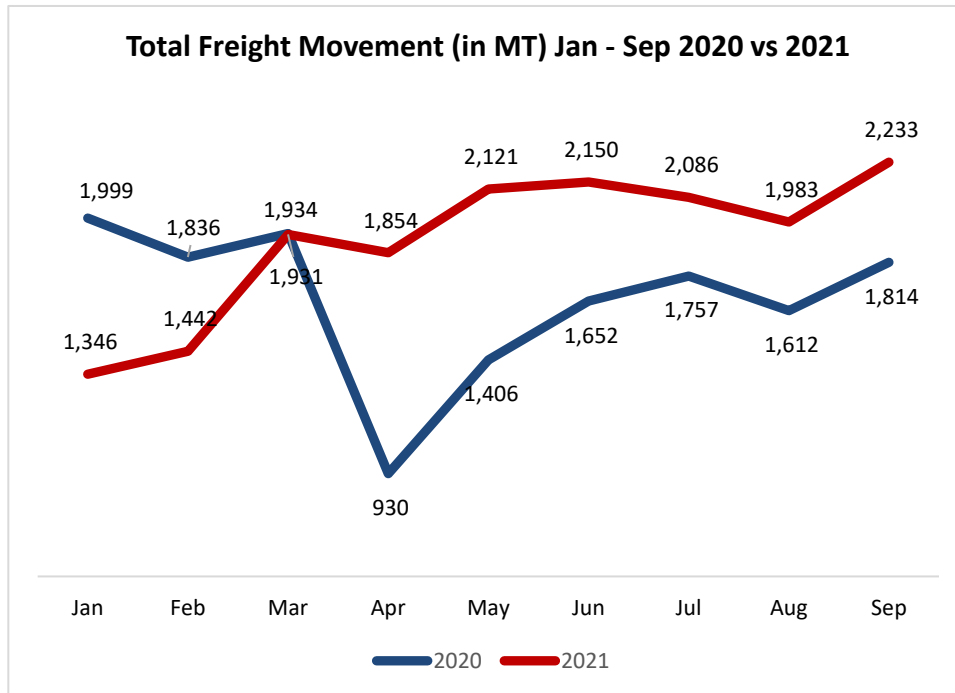
Aircraft Movements at Domestic Aerodromes Jul - Sep 2020



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period July to September 2021 were **6,325 metric tonne (MT)**, which represents a **22%** increase in freight movement from **5,183 MT** in the same period of 2020. Freight movement for the reporting period at NMIA was **5,256MT**; **1,808MT** loaded freight and **3,448** unloaded freights. On the other hand, SIA contributed **1,046MT** of freight, **883MT** loaded and **163MT** of unloaded freight.

For the reporting year 2021 freight movement increased by **15%** coming from **14,940MT** in 2020 to **17,169MT** in the year 2021.



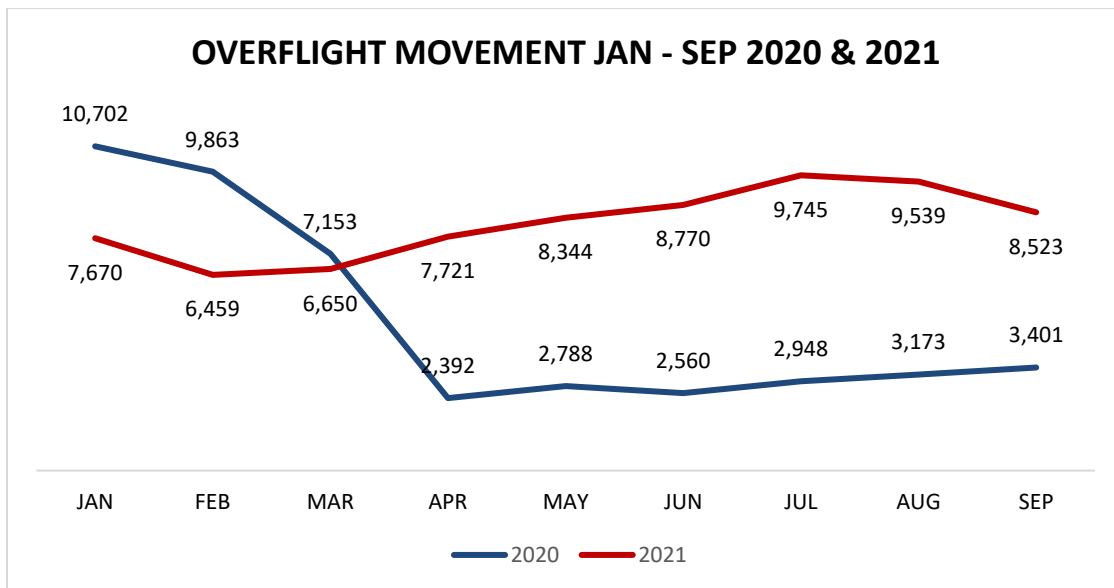

Overflight Aircraft Movements

In the third quarter of 2021, July to September, Jamaica FIR recorded a total overflight aircraft movement of **27,807**, this represents an increase of **192%** from the **9,522** overflight aircraft movements in 2020. The average number of daily overflights for the period July to September 2020 and 2021 were **103** and **302** respectively.

Year to date, January to September 2021, overflight movement increased by **63%** with **73,421** overflight movements compared to **44,980** overflights in 2020.

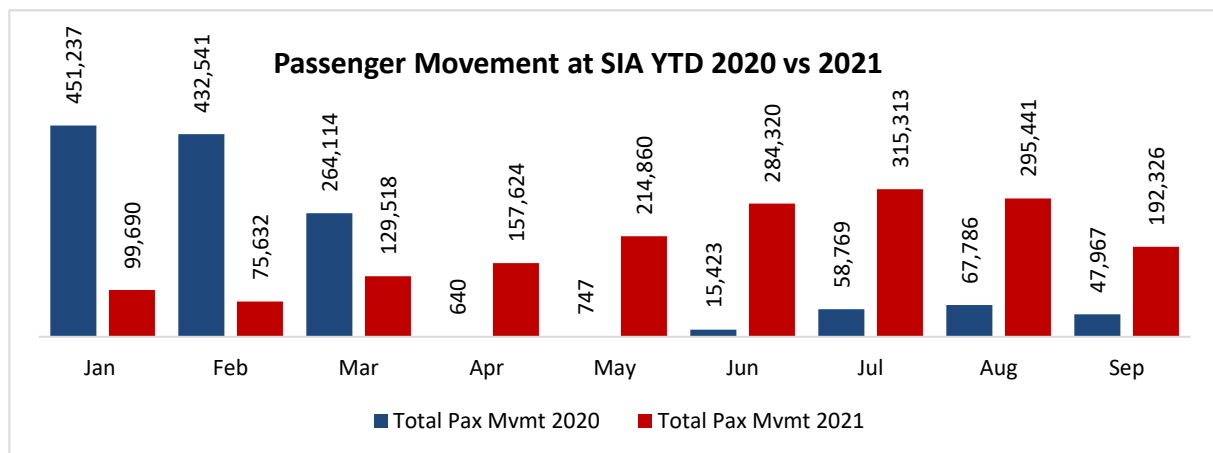
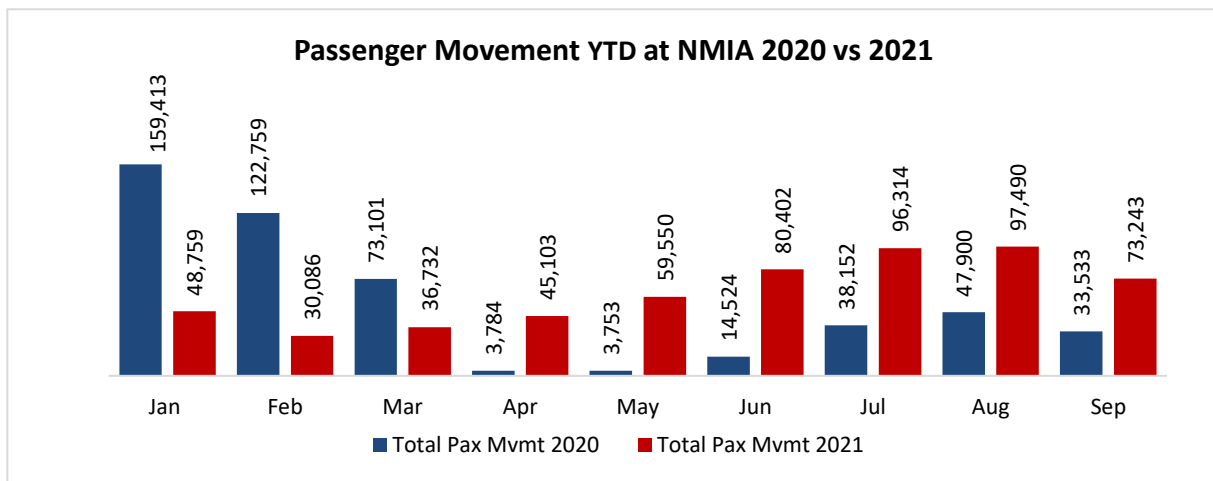
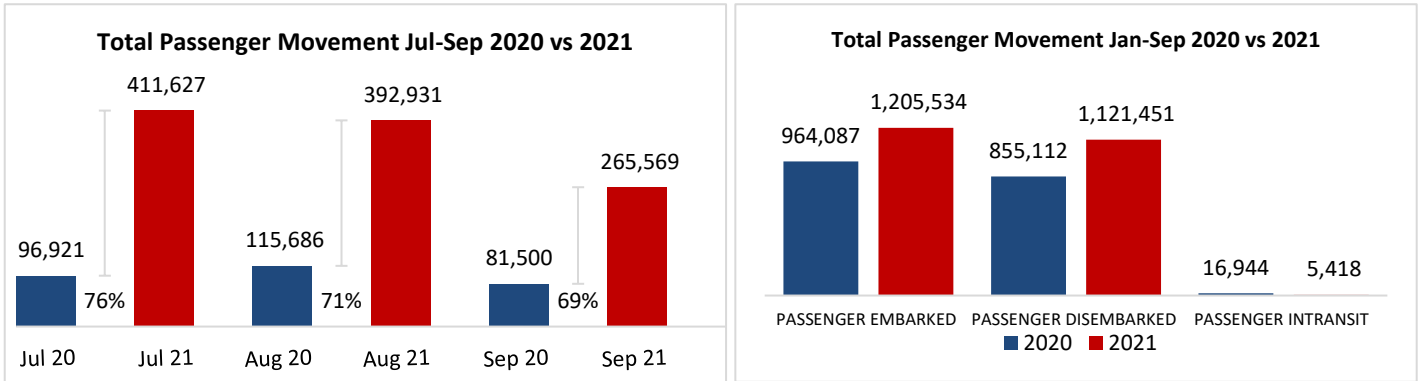

Passenger Movements at NMIA & SIA

Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the third quarter 2021 was **1,070,127** an increase of **264%** from the figure reported for the same period in 2020, which was **294,107** departures, arrivals and transit passengers.

Year to date, January to June September, passenger movements increased by **27%**, with **2,332,403** passenger arrivals and departures compared to **1,836,143** in 2020.

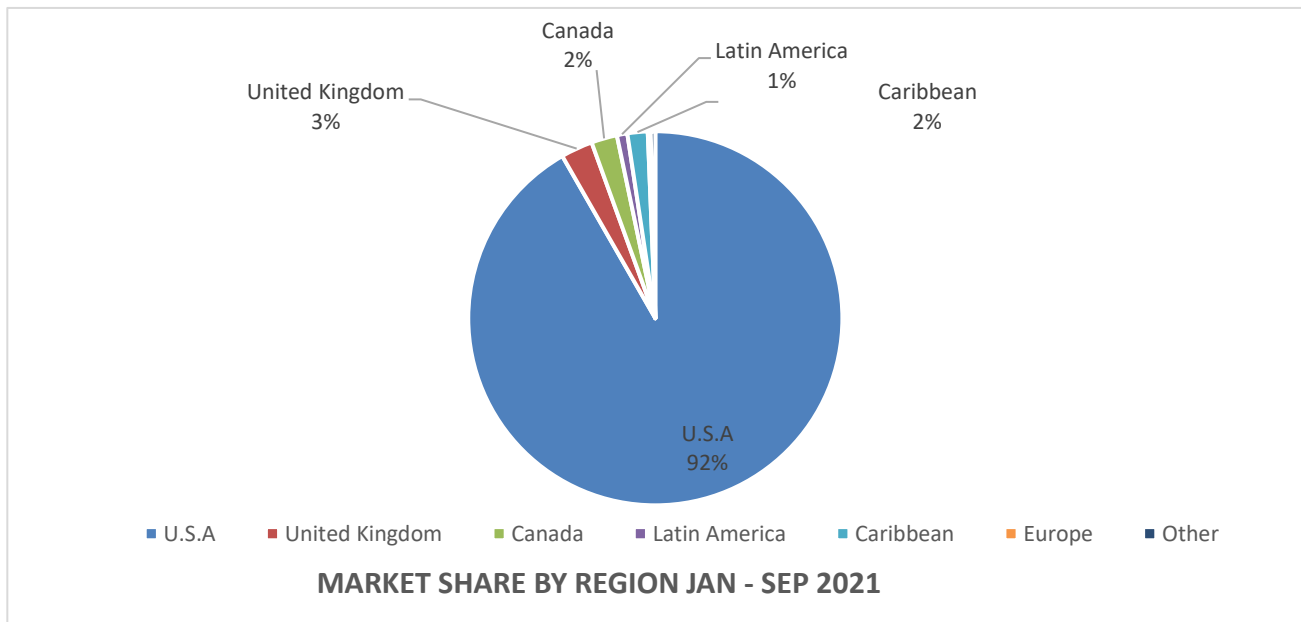

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **517,318**. This is an increase of **257%** from the passenger movement of **144,802** arrivals reported for the same period in 2020. Year to date, passenger arrivals are up **31%**, that is **1,121,451** arrivals from January – September 2021 versus **855,112** arrivals for same period in 2020.

Passenger Arrival by Airlines and Load Factor

The table below depicts the distribution of passenger arrivals by airline carriers for the period January to September 2021 period. Topping the list with the most passenger arrivals by carrier we find American Airlines with approximately **321,000** passengers, followed by JetBlue Airlines with approximately **298,000** passengers, thirdly we have Delta Airline with approximately **169,000** passengers.

Load Factor is calculated by dividing the total number of passengers carried by an aircraft by the total number of seats available on that aircraft, **expressed as a percentage**. The year-to-date load factor is approximately **67%**.
