Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period April to June 2022 were **15,679**, an increase of **38%** when compared to the **11,389** aircraft movement recorded in the same quarter in 2021.

Year to date, January to June 2022, aircraft movements at SIA & NMIA increased by **48%**, with **31,484** aircraft movements compared to **21,244** in 2021.

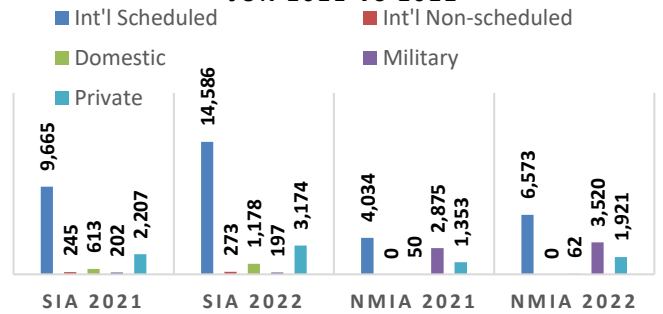
Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the second quarter 2022 totaled **6,105**, an increase of **40%** when compared to same period in 2021 where movements were **4,360**. Of the total aircraft for the 2022 period, **3,349** were international scheduled aircraft, **27** domestic aircraft, **1,773** military aircraft and **956** private aircraft. For the 2021 period of the **4,360** aircraft, **2,125** were international scheduled aircraft, **23** domestic aircraft, **1,552** military aircraft and **660** private aircraft.

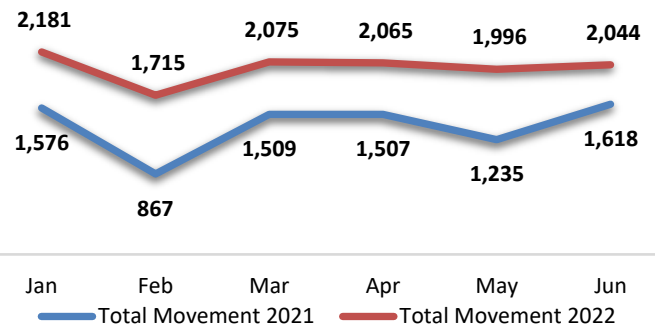
Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the second quarter of 2022 were **9,574** compared to **7,029** aircraft in the same period in 2021, an increase of **36%**. Of the aircraft for the 2022 reporting period **7,214** were international scheduled, **137** international non-scheduled, **567** domestic aircraft, **94** military aircraft and **1,562** were private aircraft. For the 2021 period of the aircraft **5,239** were international scheduled, **145** international non-scheduled, **318** domestic aircraft, **124** military aircraft and **1,203** private aircraft.

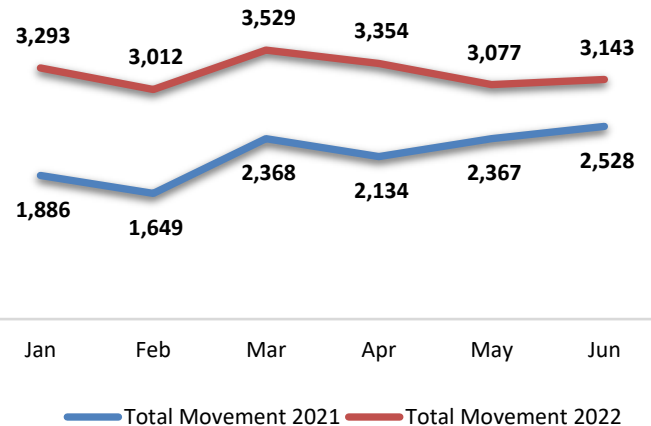
AIRCRAFT MOVEMENT SIA & NMIA JAN - JUN 2021 VS 2022

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period April to June 2022 at the domestic aerodromes and IFIA were **3,346** an increase of **55%** from the **2,163** aircraft recorded for the same period in 2021.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **103%** to **1,896** aircraft; **946** arrivals and **950** departures, conversely for same period in 2021, **932** aircraft were recorded; **472** arrivals and **460** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the April to June 2022 period. Movements increased by **12%** to **1,110** aircraft from **991** aircraft reported for the 2021 period. The 2022 period recorded equal arrivals and departures whereas the 2021 period recorded **496** and **495** arrivals and departure respectively.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA increased by **38%** to **216** with 106 arrivals and 110 departures. Movements for the 2021 period were **156** aircraft with **equal** landings and takeoffs.

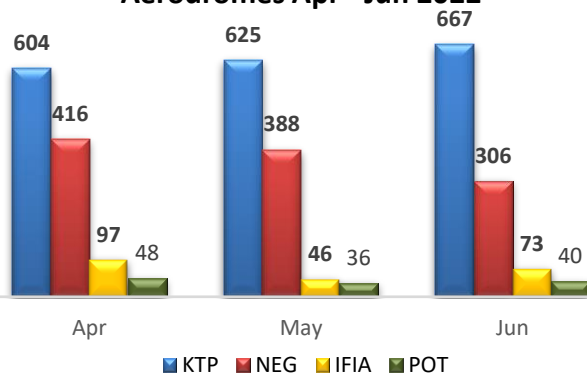
KEN JONES (POT)

Ken Jones Aerodrome noted **124** aircraft movement from April to June 2022. This was a **48%** rise from **84** aircraft arrivals and departure for the period in 2021. There were equal arrivals and departures for the 2022 and 2021 reporting periods.

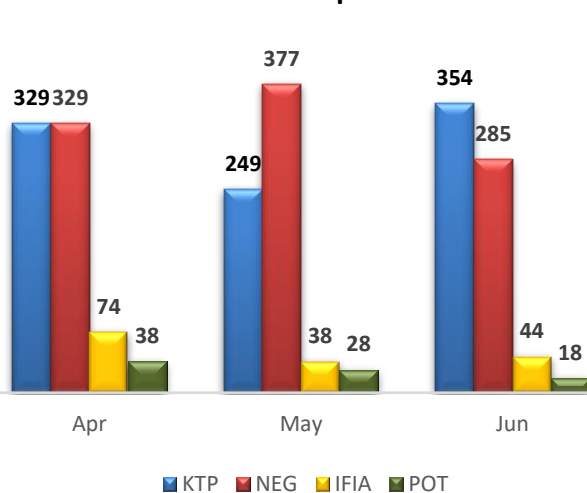

Aircraft Movements at Domestic Aerodromes Apr - Jun 2022



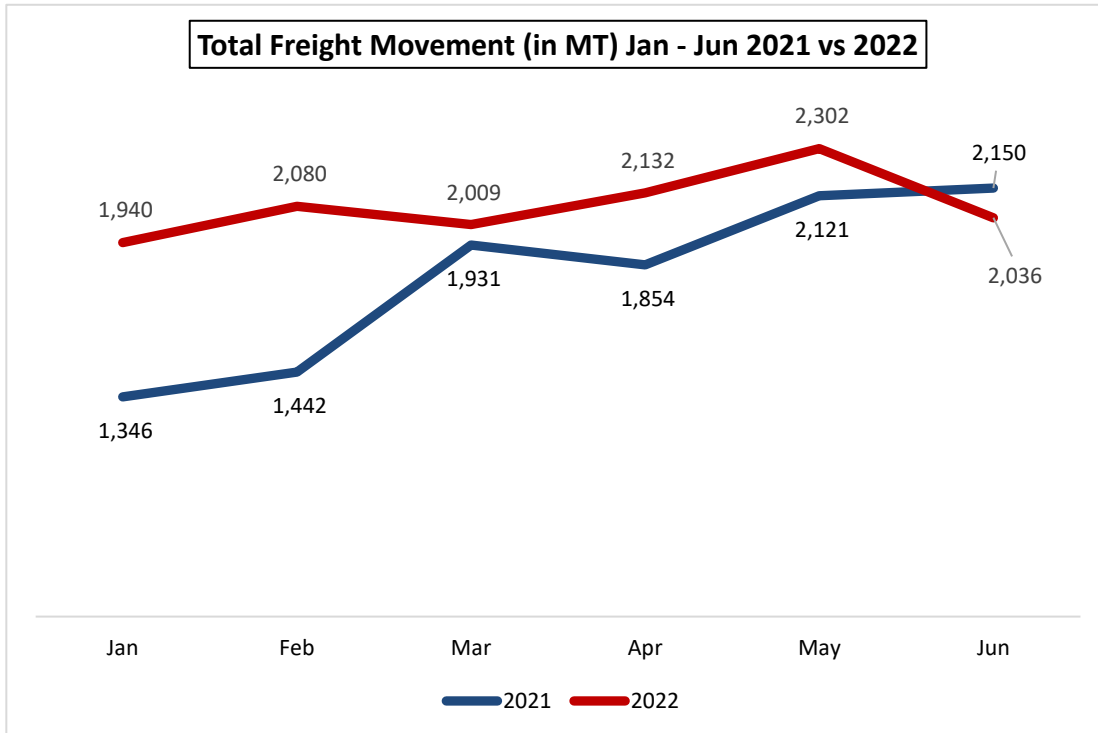
Aircraft Movements at Domestic Aerodromes Apr - Jun 2021



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period April to June 2022 were **6,470 metric tonne (MT)**, which represents a **6%** increase in freight movement from **6,125 MT** for the same period of 2021. Freight movement for the reporting period at NMIA was **4991**; **1,349MT** loaded freight and **3,642MT** unloaded freights. On the other hand, SIA contributed **1,479MT** of freight, **1,246MT** loaded and **233MT** of unloaded freight.

Year to date 2022 freight movement increased by **15%** coming from **10,844MT** in 2021 to **12,499** in the year 2022.



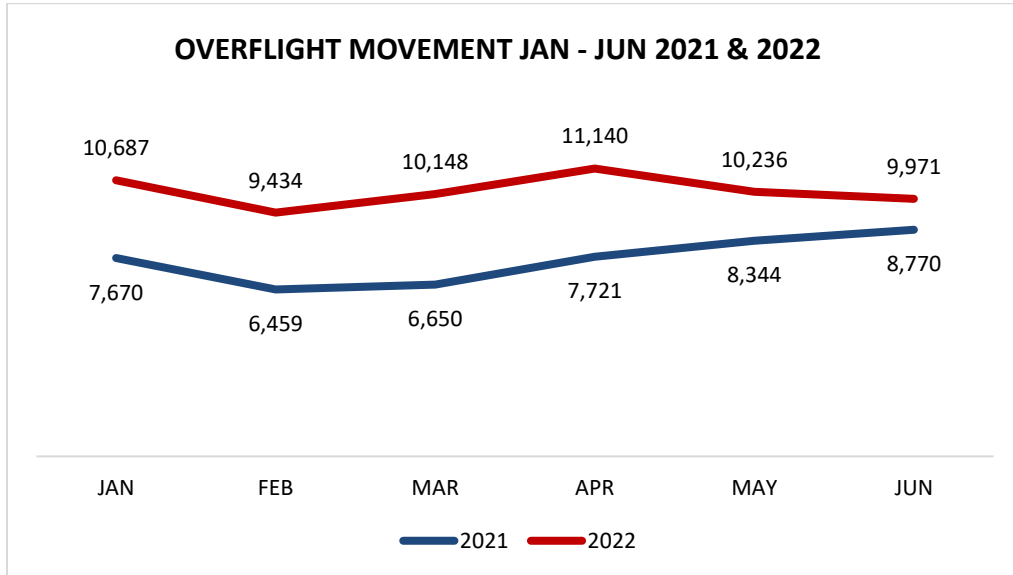

Overflight Aircraft Movements

In the second quarter of 2022, April to June, Jamaica FIR recorded a total overflight aircraft movement of **31,347**, this represents an increase of **26%** from the **24,835** overflight aircraft movements in 2021. The average number of daily overflights for the period April to June 2021 and 2022 were **272** and **344** respectively.

Year to date, January to June 2022, overflight movement increased by **35%** with **61,616** overflight movements compared to **45,614** overflights in 2021.



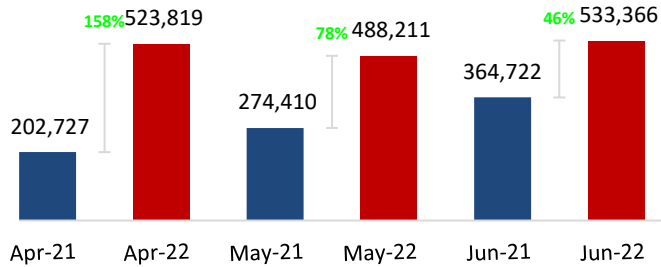

Passenger Movements at NMIA & SIA

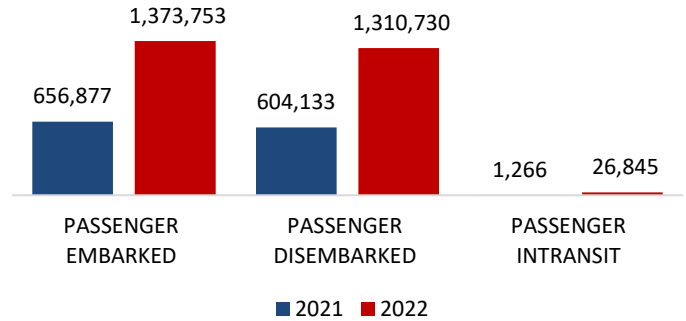
Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the second quarter 2022 was **1,545,396** an increase of **84%** from the figure reported for the same period in 2021, which was **841,859** departures, arrivals and transit passengers.

Year to date, January to June 2022, passenger movements increased by **115%**, with **2,711,328** passenger movements compared to **1,262,276** in 2021.

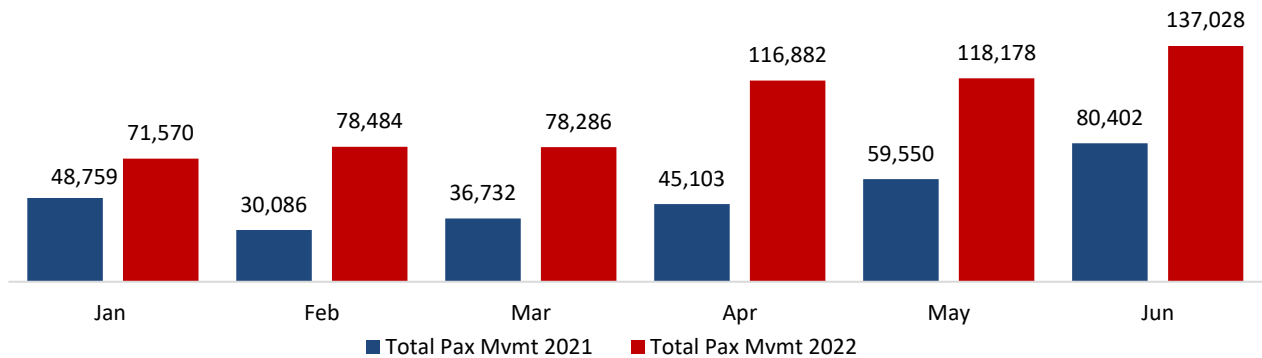
Total Passenger Movement Apr-Jun 2021 vs 2022



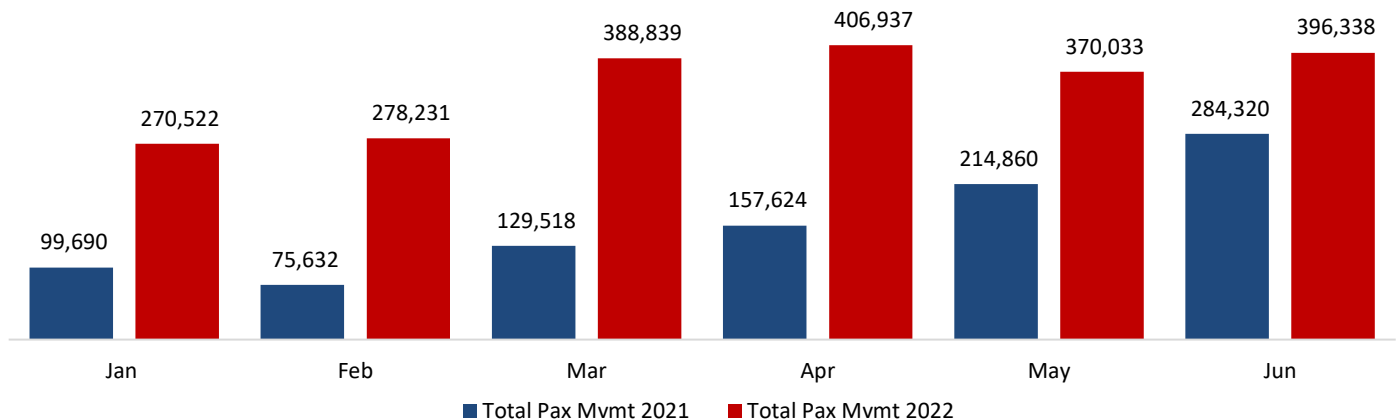
Total Passenger Movement Jan-Jun 2021 vs 2022

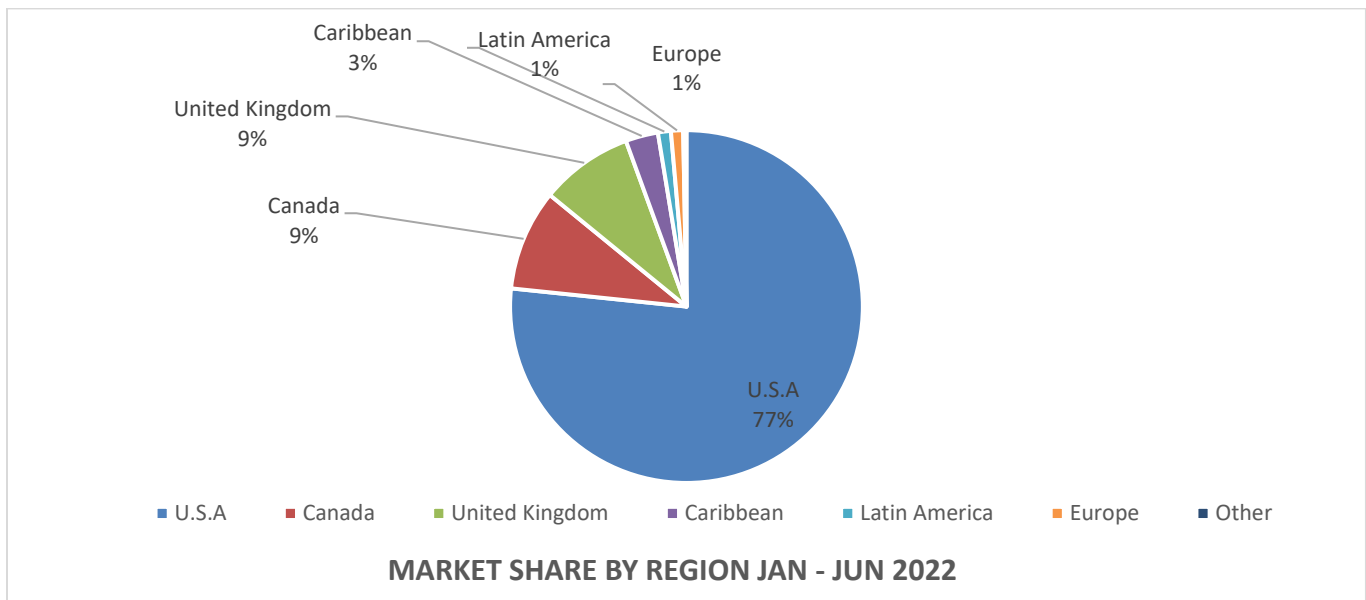

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **748,059**. This represents an increase of **82%** from the figure of **410,678** arrivals reported for the same period in 2021. Year to date, passenger arrivals are up **117%**, that is **1,310,730** arrivals from January – June 2022 versus **604,133** arrivals for same period in 2021.

Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **78% (1,026,810)** of total arrivals for the January to June 2022 reporting period. Total arrivals at NMIA for the same period was **283,920** or **22%**.

The load factor for total arrivals for the period January to June 2022 was **75%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **76%** of all international flights were occupied whereas approximately **72%** were occupied at NMIA.
