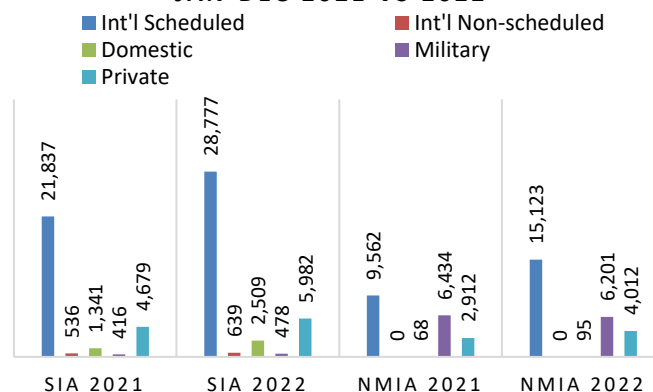


Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster’s International Airport (SIA) for the period October to December 2022 were **16,271**, an increase of **12%** when compared to the **14,508** aircraft movement recorded in the same quarter in 2021.

Year to date, January to December 2022, aircraft movements at SIA & NMIA increased by **34%**, with **63,816** aircraft movements compared to **47,785** in 2021.

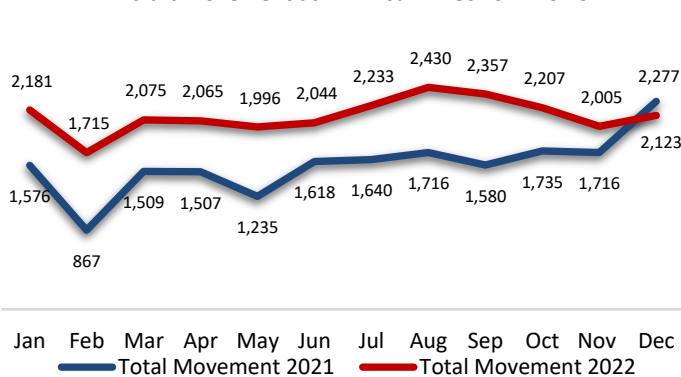
AIRCRAFT MOVEMENT SIA & NMIA JAN-DEC 2021 VS 2022



Norman Manley International Airport

Aircraft movements at NMIA for the fourth quarter 2022 totaled **6,335**, an increase of **11%** when compared to same period in 2021 where movements were **5,728**. Of the total aircraft for the 2022 period, **4,118** were international scheduled aircraft, **1,159** military aircraft and **988** private aircraft. For the 2021 period of the **5,728** aircraft, **2,994** were international scheduled aircraft, **2** domestic aircraft, **1,943** military aircraft and **789** private aircraft.

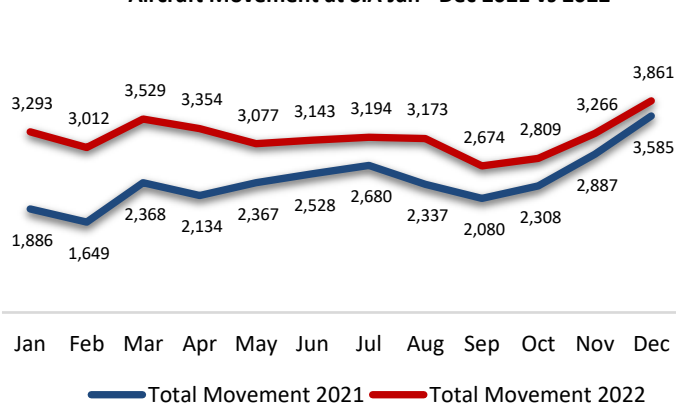
Aircraft Movement at NMIA Jan - Dec 2021 VS 2022



Sangster’s International Airport (SIA)

At the SIA, total aircraft movements in the fourth quarter of 2022 were **9,936** compared to **8,780** aircraft in the same period in 2021, an increase of **13%**. Of the aircraft for the 2022 reporting period **7,170** were international scheduled, **191** international non-scheduled, **797** domestic aircraft, **130** military aircraft and **1,648** were private aircraft. For the 2021 period of the aircraft **8,780** aircraft, **6,640** were international scheduled, **146** international non-scheduled, **443** domestic aircraft, **145** military aircraft and **1,406** private aircraft.

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period October to December 2022 at the domestic aerodromes and IFIA were **3,658** an increase of **21%** from the **2,906**, aircraft recorded for the same period in 2021.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **25 %** to **1,742** aircraft; **875** arrivals and **867** departures, conversely for same period in 2021, **1,305** aircraft were recorded; **656** arrivals and **649** departures.

NEGRIL (NEG)

Negril Aerodrome also reported an increase in aircraft movement for the October to December 2022 period. Movements increased by **26%** to **1,513** aircraft from **1,120** aircraft reported for the 2021 period. The 2022 period recorded **758** arrivals and **755** departures whereas the 2021 period recorded equal aircraft arrivals and departure of **560**.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA decreased by **70%** to **227** with **113** arrivals and **114** departures. Movements for the 2021 period were **385** aircraft with **193** landings and **192** takeoffs.

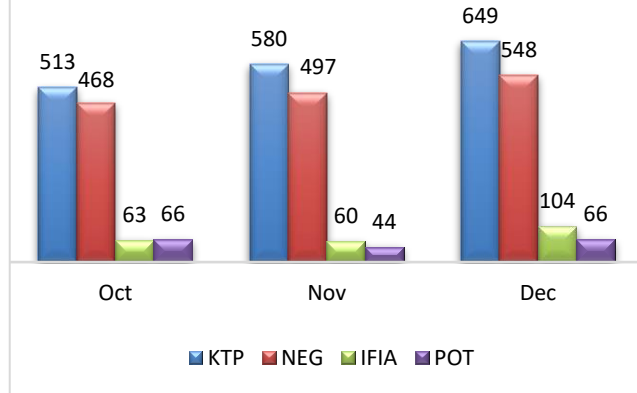
KEN JONES (POT)

Ken Jones Aerodrome noted **176** aircraft movement from October to December 2022. This was a **5%** rise from **96** aircraft arrivals and departure for the period in 2021. There were equal arrivals and departures for the 2022 and 2021 reporting periods.

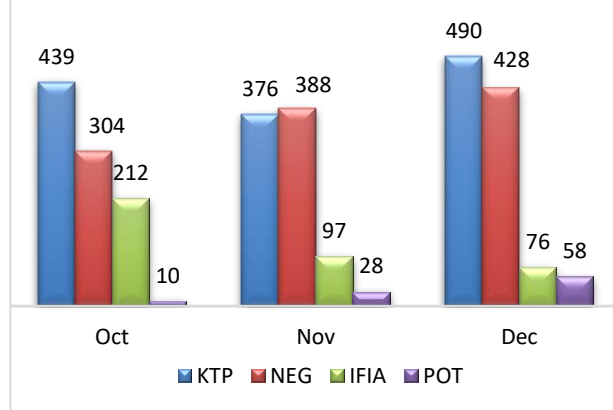

Aircraft Movements at Domestic Aerodromes Oct - Dec 2022



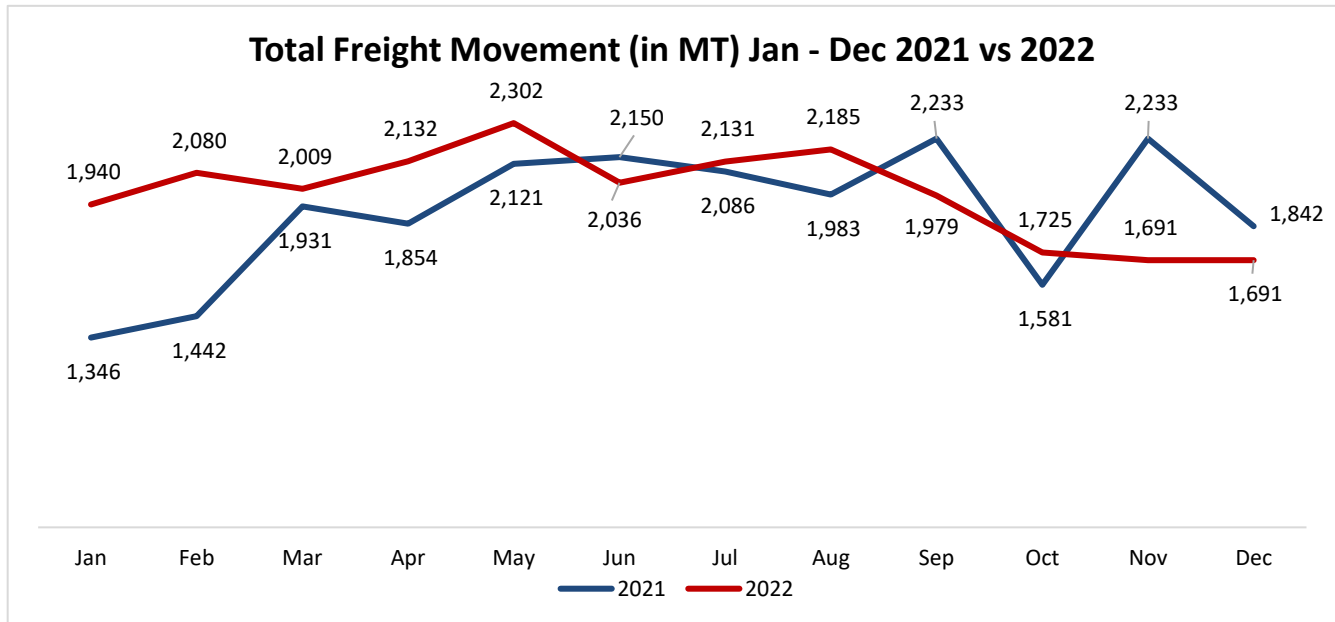
Aircraft Movements at Domestic Aerodromes Oct - Dec 2021



CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the quarter October to December 2022 were **5,107 metric tonne (MT)**, which represents a decrease of **10%** in freight movement from **5,656MT** for the same period of 2021. Freight movement for the reporting period at NMIA was **3,872**; **1,624MT** loaded freight and **2,248MT** unloaded freights. On the other hand, SIA contributed **1,235MT** of freight, **967MT** loaded and **268MT** of unloaded freight.

Year to date 2022 freight movement increased by **31%** coming from **18,320MT** in 2021 to **23,901MT** in the year 2022.



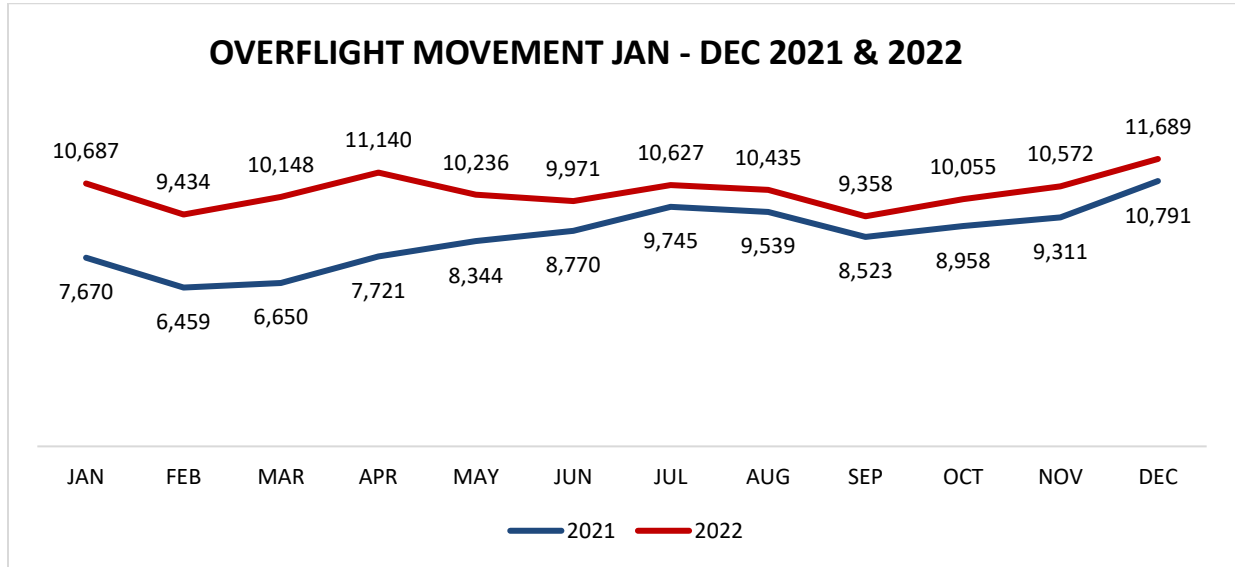

Overflight Aircraft Movements

In the fourth quarter of 2022, October to December, Jamaica FIR recorded a total overflight aircraft movement of **32,316**, this represents an increase of **11%** from the **29,060** overflight aircraft movements in 2021. The average number of daily overflights for the period October to December 2021 and 2022 were **315** and **351** respectively.

Year to date, January to December 2022, overflight movement increased by **21%** with **124,352** overflight movements compared to **102,481** overflights in 2021.



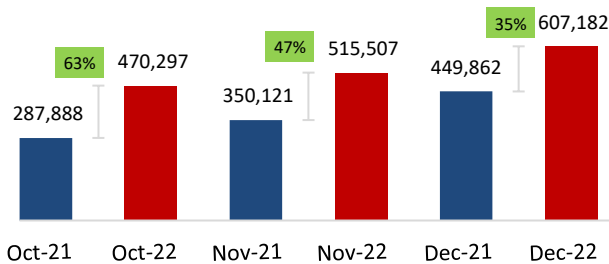

Passenger Movements at NMIA & SIA

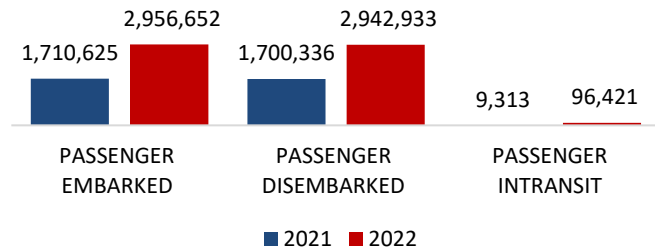
Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the fourth quarter 2022 was **1,592,986** an increase of **46%** from the figure reported for the same period in 2021, which was **1,087,871** departures, arrivals and transit passengers.

Year to date, January to December 2022, passenger movements increased by **75%**, with **5,996,006** passenger movements compared to **3,420,274** in 2021.

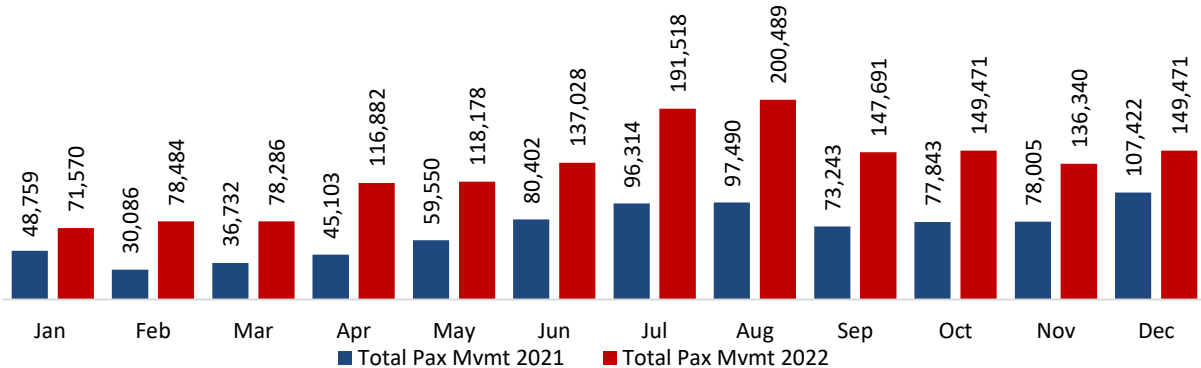
Total Passenger Movement Oct - Dec 2021 vs 2022



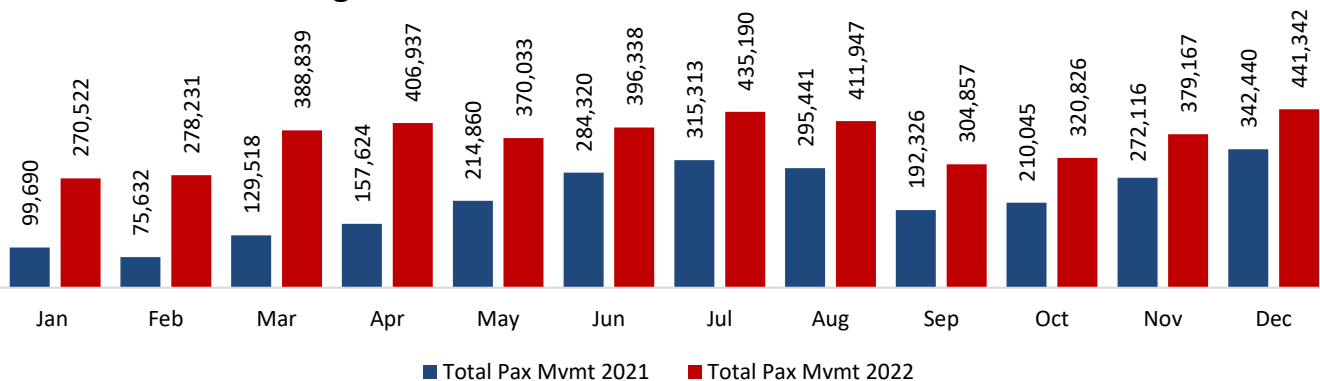
Total Passenger Movement January - December 2021 vs 2022

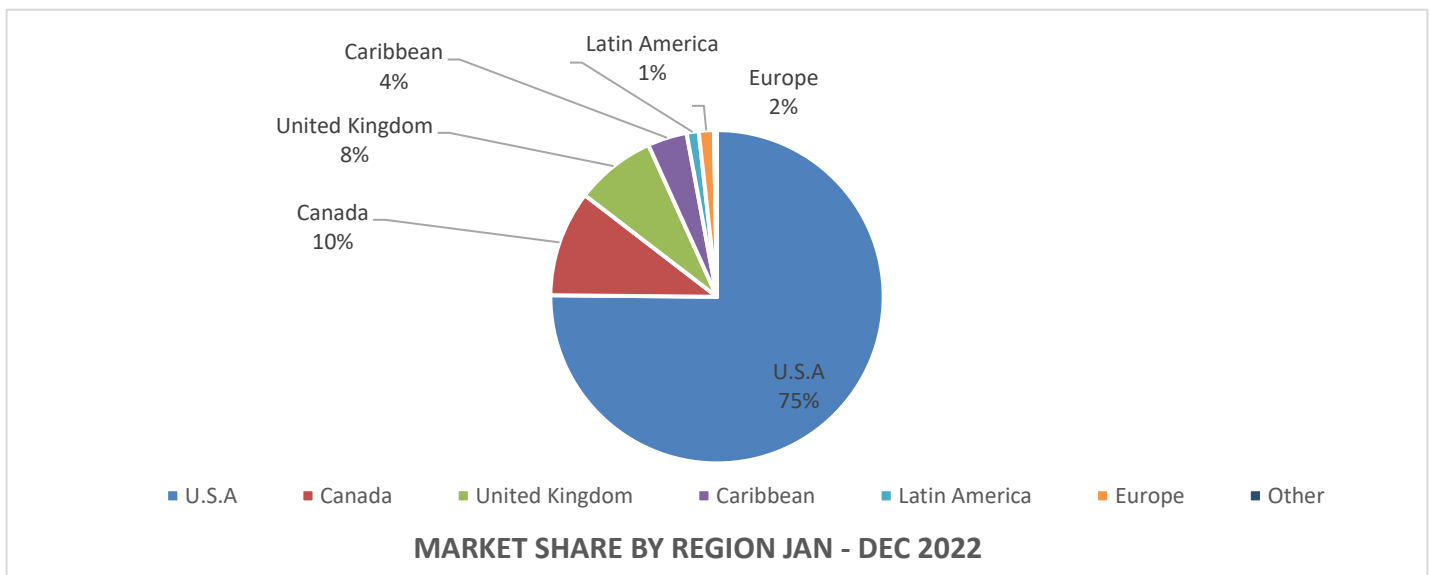

Passenger Arrival by Region

Total passenger arrivals for the reporting period were **829,697**. This represented an increase of **56%** from **578,885** arrivals reported for the same period in 2021. Year to date, passenger arrivals are up **73%**, that is **2,942,933** arrivals from January to December 2022 versus **1,700,336** arrivals for same period in 2021.

Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **74% (2,174,506)** of total arrivals for the January to December 2022 reporting period. Total arrivals at NMIA for the same period was **768,427** or **26%**.

The load factor for total arrivals for the period January to December 2022 was **81%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At SIA, approximately **82%** of all international flights were occupied whereas approximately **79%** were occupied at NMIA.
