Aircraft Movement – NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster’s International Airport (SIA) for the period January to March 2024 were **18,832**, an increase of **7%** when compared to the **17,522** aircraft movement recorded in the same quarter in 2023.

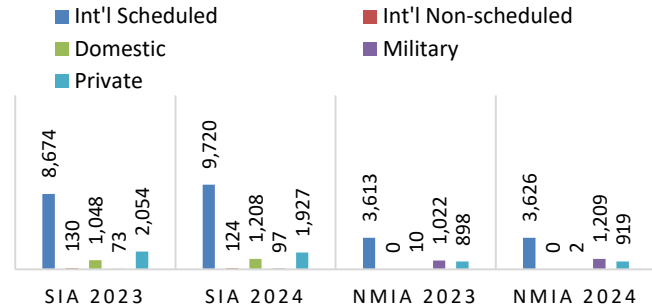
Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the first quarter 2024 increased by **4%** to **5,756** when compared to same period in 2023 where movements were **5,543**. Of the total aircraft for the 2024 period, **3,626** were international scheduled aircraft, **2** domestic aircraft, **1,209** military aircraft and **919** private aircraft. Of the **5,543** aircraft for the 2023 period, **3,613** were international scheduled aircraft, **10** domestic aircraft, **1,022** military aircraft and **898** private aircraft.

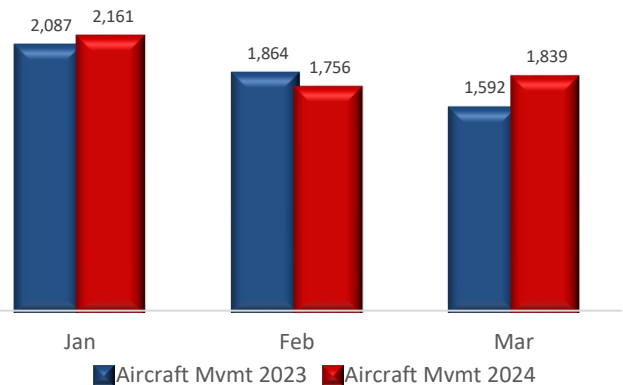
Sangster’s International Airport (SIA)

At the SIA, total aircraft movements in the first quarter of 2024 were **13,076** compared to **11,979** aircraft in the same period in 2023, an increase of **9%**. Of the **13,076** aircraft for the 2024 reporting period **9,720** were international scheduled, **124** international non-scheduled, **1,208** domestic aircraft, **97** military aircraft and **1,927** were private aircraft. Of the **11,979** aircraft for the 2023 period **8,674** were international scheduled, **130** international non-scheduled, **1,048** domestic aircraft, **73** military aircraft and **2,054** were private aircraft.

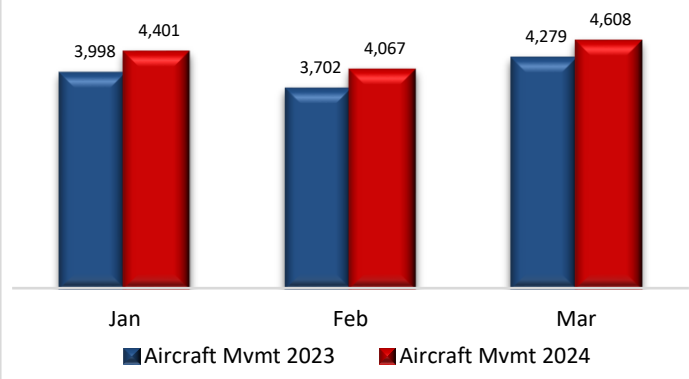
AIRCRAFT MOVEMENT SIA & NMIA JAN - MAR 2023 VS 2024

AIRCRAFT MOVEMENT – KTP, NEG, IFIA, POT

Overall aircraft movements for the period January to March 2024 at the domestic aerodromes and IFIA were **4,315** an increase of **8%** from the **4,004** aircraft recorded for the same period in 2023.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the reporting period increased by **7%** to **1,934** aircraft; **973** arrivals and **961** departures, conversely for same period in 2023, **1,800** aircraft were recorded; **894** arrivals and **906** departures.

NEGRIL (NEG)

Negril Aerodrome reported a slight increase in aircraft movement for the January to March 2024 period. Movements increased slightly by **0.2%** to **1,871** aircraft from **1,867** aircraft reported for the 2023 period. The 2024 period recorded **937** arrivals and **934** departures whereas the 2023 period recorded **933** arrivals and **934** departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)

Aircraft movement at IFIA for the reporting period increased by **66%** to **296** with **150** arrivals and **146** departures. Movements for the 2023 period were **178** with **91** arrivals and **87** departures.

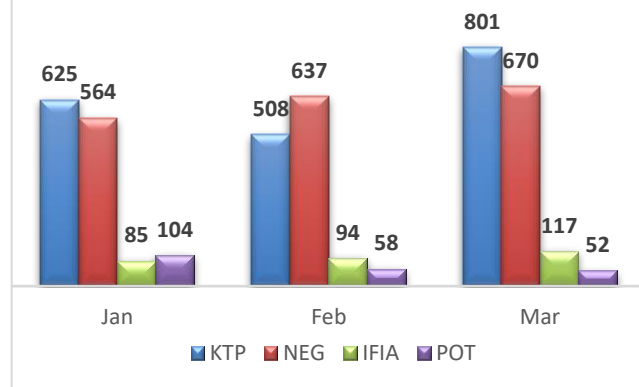
KEN JONES (POT)

Ken Jones Aerodrome recorded **214** aircraft movement from January to March 2024. This was a **35%** increase from **159** aircraft arrivals and departure for the period in 2023. There were **equal** aircraft arrivals and departures for the 2024 reporting period, whereas the 2023 reporting period had **80** aircraft arrivals **79** and departures.

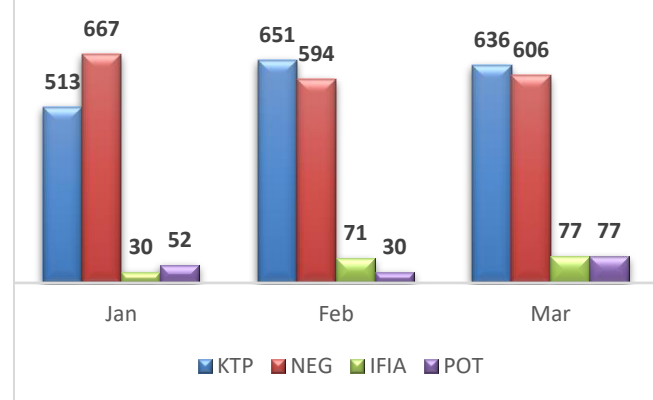

Aircraft Movements at Domestic Aerodromes Jan - Mar 2024

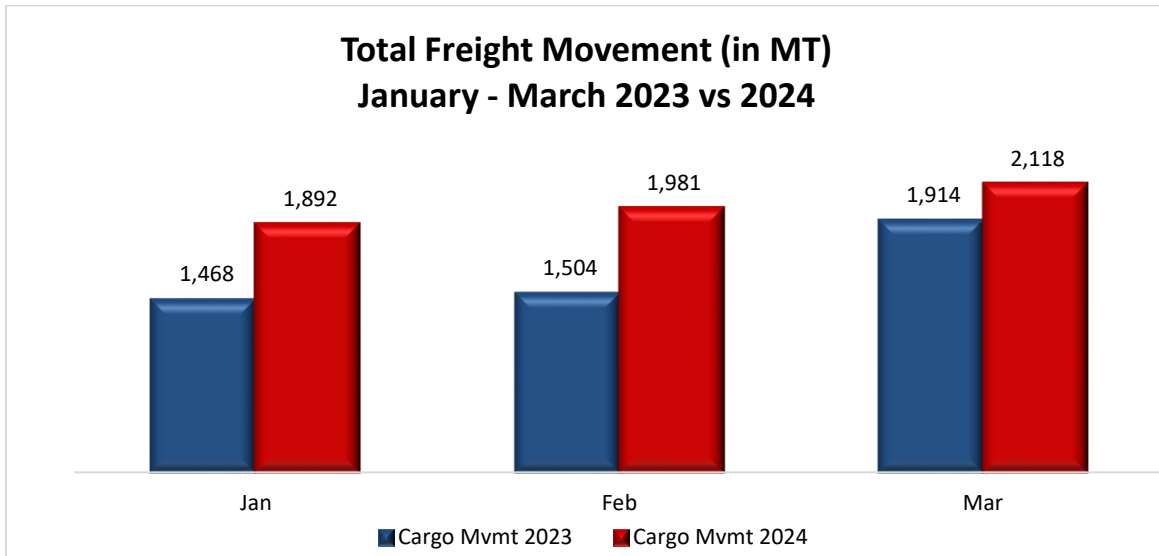


Aircraft Movements at Domestic Aerodromes Jan - Mar 2023



CARGO ACTIVITY AT NMIA & SIA

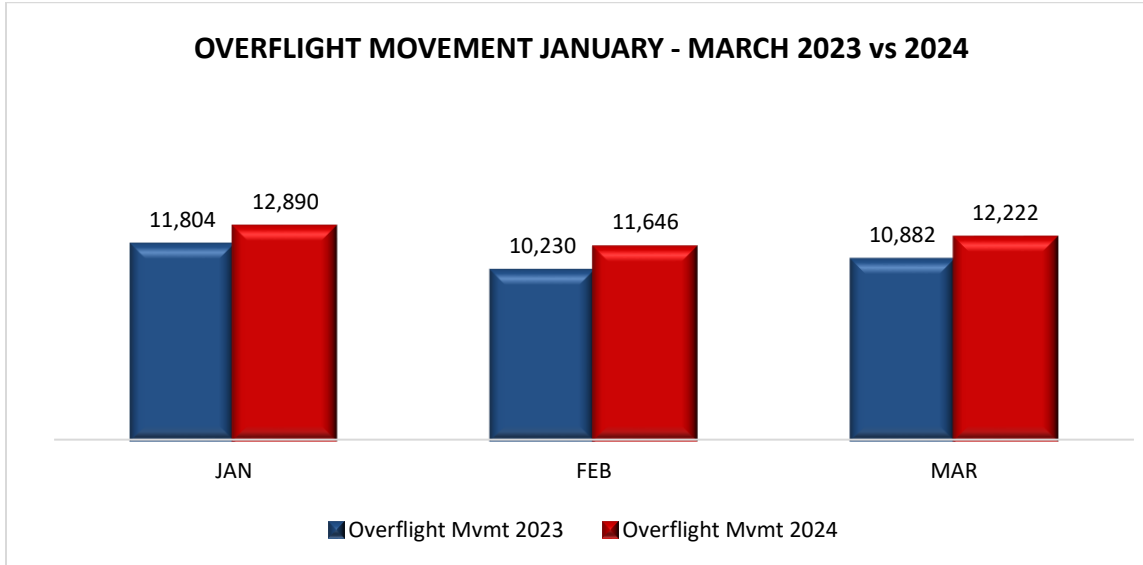
Cargo movements at the international airports NMIA and SIA for the period January to March 2024 were **5,991 metric tonne (MT)**, which represents a **34%** increase in freight movement from **4,486 MT** for the same period of 2023. Freight movement for the reporting period at NMIA was **4,559; 914MT** loaded freight and **3,645MT** unloaded freight. On the other hand, SIA contributed **1,432** of freight, **1,144 MT** loaded and **288MT** of unloaded freight.

Overflight Aircraft Movements

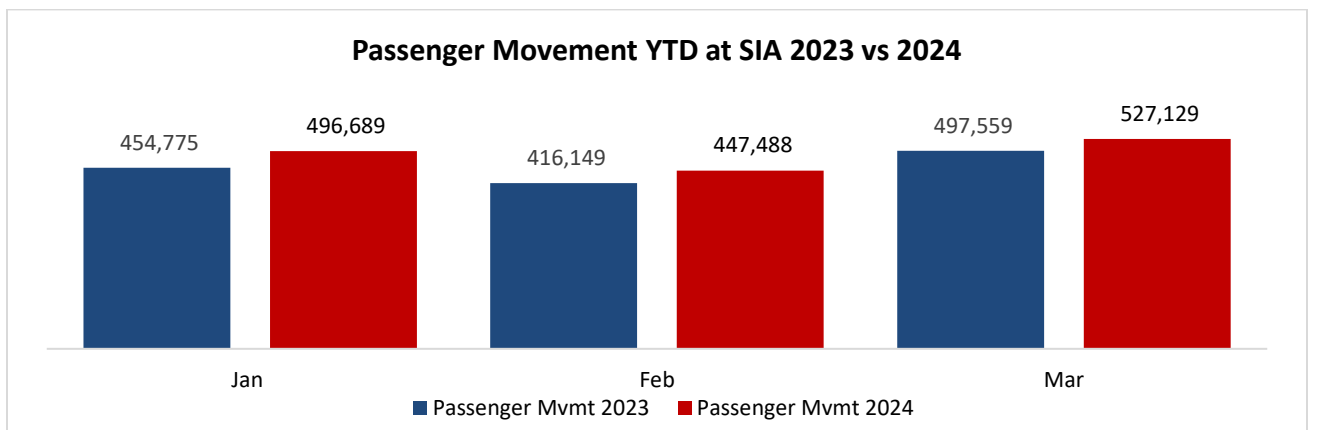
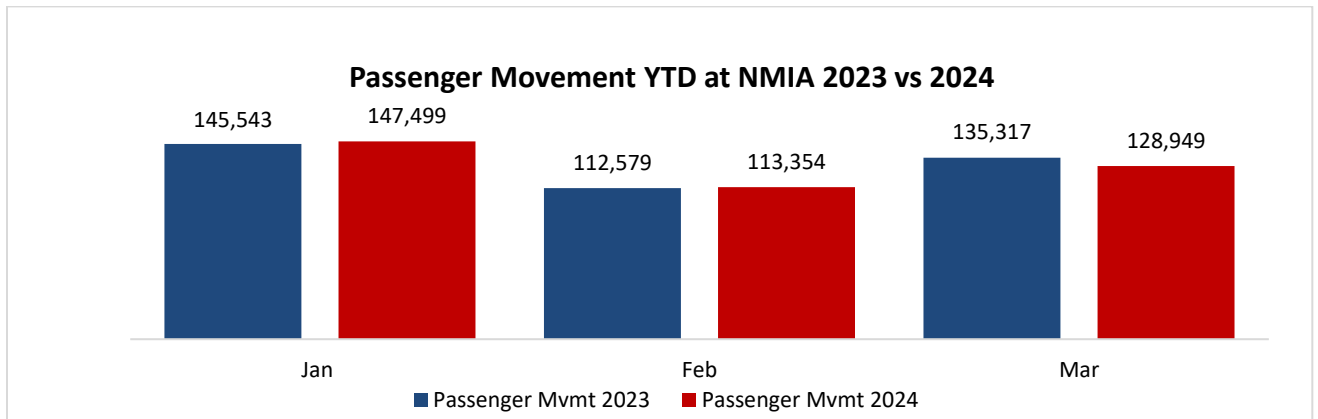
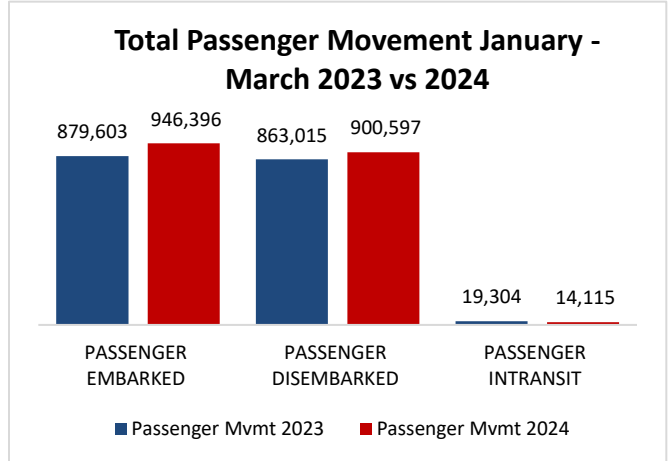
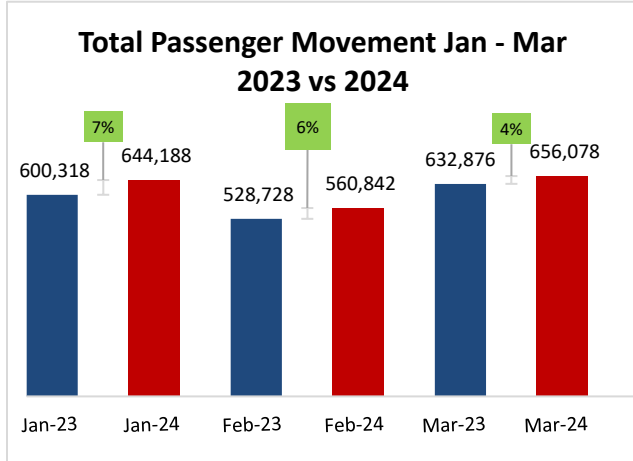
In the first quarter of 2024, January to March, Jamaica FIR recorded a total overflight aircraft movement of **36,758**, this represents an increase of **12%** from the **32,916** overflight aircraft movements in Q1 2023. The average number of daily overflights for the period January to March 2023 and 2024 were **365** and **403** respectively.

Passenger Movements at NMIA & SIA

Total passenger (includes international and domestic passengers) movements at NMIA and SIA for the first quarter 2024 was **1,861,108** an increase of **6%** from the figure reported for the same period in 2023, which was **1,761,922** departures, arrivals and transit passengers.

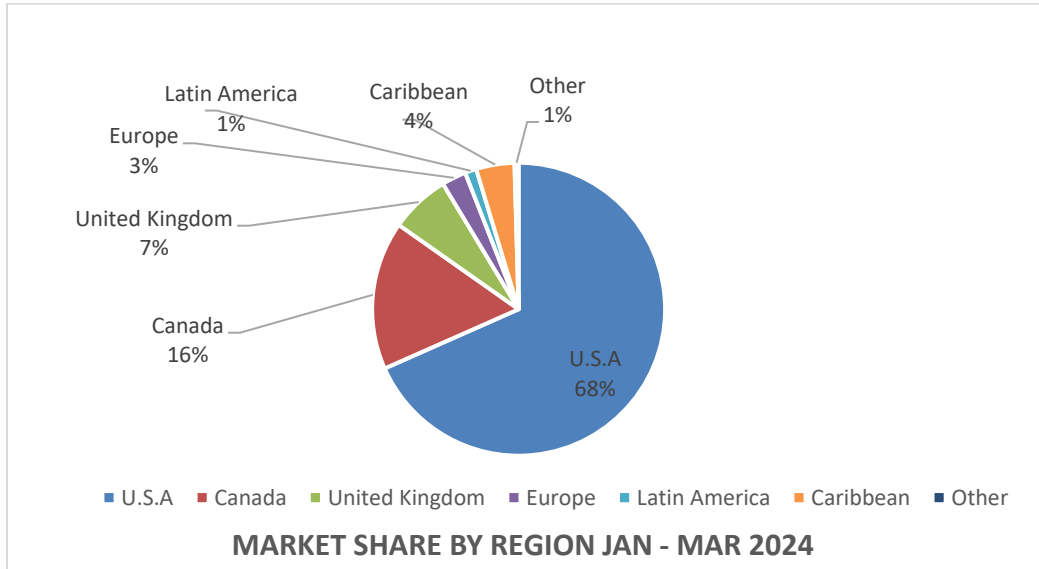

Passenger Arrival by Region

The reporting period recorded over **900,000** passenger arrivals. This represents an increase of **4%** from the figure of **863,000** arrivals reported for the same period in 2023.

Passenger Arrival by International Airports and Load Factor

Arrivals at Sangster International Airport (SIA) accounted for **79%** of total arrivals for the January to March 2024 reporting period. Total arrivals at NMIA for the same period was **21%**.

The load factor for total arrivals for the period January to March 2024 was **77%**. Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. At both SIA and NMIA, approximately **77%** of all international flights were occupied.

Permits, Flight Authorization and Licenses Issued
