Aircraft Movement - NMIA & SIA

Total aircraft movements at the Norman Manley International Airport (NMIA) and Sangster's International Airport (SIA) for the period April to June 2025 were **16,289**, a slight increase of **0.4%** when compared to the **16,222** aircraft movement recorded in the same quarter in 2024.

Year to date, January to June 2025, aircraft movements at SIA and NMIA decreased by **3%**, with **34,165** aircraft movements compared to **35,054** in 2024.


Norman Manley International Airport (NMIA)

Aircraft movements at NMIA for the second quarter 2025 totaled **6,154**, an increase of **7%** when compared to same period in 2024 where movements were **5,731**. Of the total aircraft for the 2025 period, **3,091** were arrivals and **3,063** were departures. For the 2024 period, **2,852** were arrivals and **2,879** were departures.

Sangster's International Airport (SIA)

At the SIA, total aircraft movements in the second quarter of 2025 were **10,135** compared to **10,491** aircraft in the same period in 2024 a decrease of **4%**. Of the total aircraft for the 2025 period, **5,071** were arrivals and **5,064** were departures. For the 2024 period, **5,239** were arrivals and **5,252** were departures.

Aircraft Movement at KTP, NEG, IFIA & POT

Overall aircraft movements for the period April to June 2025 at the domestic aerodromes and IFIA were **4,427** an increase of **19%** from the **3,730** aircraft recorded for the same period in 2024.

TINSON PEN (KTP)

Aircraft movement at Tinson Pen for the period April to June 2025 increased by **50%** to **2,709** aircraft; **1,402** arrivals and **1,307** departures, conversely for same period in 2024, there were **1,809** aircraft recorded; **902** arrivals and **907** departures.

NEGRIL (NEG)

Negril Aerodrome reported a decrease in aircraft movement for the April to June 2025 period. Movements decreased by 23% to 1,148 aircraft from 1,500 aircraft reported for the 2024 period. Movements for the 2025 period were 573 arrivals and 575 departures while for the 2024 period there were equal arrivals and departures.

IAN FLEMING INTERNATIONAL AIRPORT (IFIA)


Aircraft movement at IFIA for the April to June 2025 period increased by **30%** to **408** with **equal** arrivals and departures. Movements for the 2024 period were **315** aircraft with **159** landings and **156** takeoffs.


KEN JONES (POT)

Ken Jones Aerodrome noted **162** aircraft movement from April to June 2025. This was a **53%** increase from **106 aircraft** arrivals and departure for the period in 2024. There were **equal** aircraft arrivals and departures for the 2024 and 2025 periods.






CARGO ACTIVITY AT NMIA & SIA

Cargo movements at the international airports NMIA and SIA for the period April to June 2025 were **7,889 metric tonnes (MT)**, which represents a **5%** decrease in freight movement from **8,279MT** for the same period of 2024. Freight movement for the reporting period at NMIA was **6,414**; **1,017MT** loaded freight and **5,397** unloaded freight. On the other hand, SIA contributed **1,475MT** freight, **1,211MT** loaded and **264MT** unloaded freight.

Year to date 2025 freight movement increased by 12% coming from 14,270MT in 2024 to 15,978MT in the year 2025.



Overflight Aircraft Movements

In the second quarter of 2025, April to June, Jamaica FIR recorded a total overflight aircraft movement of, **35,993** this represents an increase of **1%** from the **35,780** overflight aircraft movements in 2024. The average number of daily overflights for the period April to June 2024 and 2025 were **393** and **395** respectively.

Year to date, January to June 2025, overflight movement increased by **6%** with **73,823** overflight movements compared to **72,538** overflights in 2024.







Passenger Movements at NMIA & SIA


Total passenger (including international and domestic passengers) movements at NMIA and SIA for the second quarter 2025 were **1,689,099**, a decrease of **1%** from the figure reported for the same period in 2024, which was **1,714,431** departures, arrivals and transit passengers.

Year to date, January to June 2025, passenger movements decreased by **3%**, with **3,463,823** passenger movements compared to **3,575,539** in 2024.



Passenger Arrival by Region

Total passenger arrivals for the reporting period, April to June 2025 were **832,370.** This represents a slight increase of **0.3**% from the figure of **830,089** arrivals reported for the same period in 2024. Year to date, passenger arrivals are down **3**%, that is **1,688,078** arrivals from January to June 2025 versus **1,730,686** arrivals for same period in 2024.

Passenger Movements by International Airports

Passenger movement at Sangster International Airport (SIA) accounted for **74%** of total movements for the January to June 2025 reporting period whereas at NMIA passenger movement was **26%** for the same period.

Passenger Arrivals Load Factor

Load factor is calculated by dividing the number of passengers carried by an aircraft by the total number of available seats and is **expressed as a percentage**. Year to date, January to June 2025, approximately **81%** of all international flights are occupied.
